STATEMENT ON SALES TAX UNDER PENJANA INITIATIVE.

0% for CKD Models with 2020 Manufacturing Year.

5% for CBU Models with 2020 Manufacturing Year.

In-line with recent announcement of the National Economic Recovery Plan (PENJANA) by Prime Minister YB Tan Sri Muhyiddin Yassin, the Malaysian automotive sector is set to benefit from temporary sales tax incentives for both CKD and CBU vehicles in the year of make 2020. These tax incentives are listed under the 2 key thrust of the PENJANA objective, which aims to propel local businesses and stimulate the economy as we move into the Recovery Movement Control Order (RMCO). As such, the current 10% sales tax for CKD vehicles will be fully waived to 0% while sales tax for CBU vehicles will be halved to 5%. The new sales tax incentives are only applicable for new vehicle registrations from 15 June 2020 to 31 Dec 2020.
